Urban basic services at UN Habitat covers its work on water and sanitation, energy, transport, solid waste, ICT. This work covers all three pillars of the UN: humanitarian response, peace and security and development.

Andre Dzikus has been with UN-Habitat for more than 30 years and managed large projects and programmes in Africa, Asia and Latin America. He was instrumental in setting up the Water and Sanitation Trust Fund (WSTF) to address the MDGs, which was converted into an Urban Basic Services Trust Fund in response to the adoption of the Agenda 2030 by member states. Andre holds a degree in Urban Geography, with specialization in urban and regional planning in developing countries.

### **Priestess Beatriz Schulthess**



Priestess Schulthess has 30 years of expertise in multilateral diplomacy on behalf of Indigenous Peoples, Women and Environment and Development organisations. Priestess Schulthess currently serves as the President for the Indigenous People Ancestral Spiritual Council in Costa Rica. She has previously served as a consultant in preparation for and in negotiations of the United Nations Conference on Environment and Development, also known as the 'Earth Summit,' and was subsequently engaged in the monitoring and follow up of the Climate Change and Rio + 20 negotiation processes. She founded and co-founded various organisations, notably the Indigenous Peoples Ancestral Spiritual Council. In addition, she was the Executive Director of the International Indigenous Commission from 1989 to 1992.Priestess Schulthess was instrumental in negotiations which led to the Proclamation of the International Year of the World's Indigenous Peoples, 1993, as well as in the drafting of the Universal Declaration of the Rights of Indigenous Peoples.

She has compiled and edited librettos for two works by Philip Glass: Symphony No. 5: Bardo, Requiem and Nirmāņakāya (1999) and The Passion of Ramakrishna (2006). Kusumita has been a student of Sri Chinmoy (1931-2007) since 1971 and is the author of The Philosophy of Sri Chinmoy: Love and Transformation (Lexington Books, 2021).

Rev. Dr. Michael Reid Trice is Spehar-Halligan Professor and Director of the Center for Ecumenical and Interreligious Engagement at Seattle University. Trice is also the founder of Religica, a popular virtual and multimedia platform that highlights religious traditions, spiritual pathways, and indigenous wisdom as virtues of public life. The Religica Theolab Podcast collaborates with national and global partners for a growing distribution.

Trice's book Encountering Cruelty (2009) won the humanities award at Loyola University. He is currently co-editing a forthcoming text Injury, Repair and Gratitude in a Pandemic Age. He participates in the PWR-Vatican Ecology Writing Group, was a fellow at both the American Association for the Advancement of Science in Seminaries program as well as at the Shalom Hartman Institute.



Dr. Laurel Kearns co-founded the Green Seminary Initiative, and is Professor of Ecology, Society and Religion at Drew Theological School in New Jersey, USA where she has taught since 1994. During this time, she has helped eco-justice to become rooted in the Drew curriculum so that there is now a required course: Global Faiths and the Earth.

Her research is focused on religious involvement in ecological issues and movements, with a particular interest in environmental justice, climate change, and food. In addition to EcoSpirit: Religions and Philosophies for the Earth, she has contributed chapters to volumes such as, The Oxford Handbook on Climate Change and Society, Grassroots to Global: Broader Impacts of Civic Ecology, Quakers, Creation Care, and Sustainability, Living Cosmology: Christian Responses to the Journey of the Universe and the Bloomsbury Handbook on Religion and Nature. Ursula Goodenough is Professor of Biology Emerita at Washington University with a Ph.D. from Harvard in 1969; she has been living by the ocean on Martha's Vineyard since 2017. She has served in several IRAS leadership positions and co-chaired 6 conferences. Her interest in the religious naturalist orientation was birthed at IRAS and lead to a book (The Sacred Depths of Nature) and many articles in Zygon. She participated in the founding of the Religious Naturalist Association (RNA) in 2014 and currently serves as its president. She has 5 children and 8 grandchildren.

Rt. Rev Dr. Malayil Sabu Koshy Cherian is the 13th Bishop of the Madhya Kerala Diocese, Church of South India. He earned BSc in Mathematics, PGDCA, B.Ed, and MA in Sociology. Later he received his Bachelor of Divinity (BD) from UBS, Pune and Doctor of Ministry from New York Theological Seminary.

He started his ministry as a missionary in the Andhra Mission, where he spearheaded medical, educational and church planting ministry in Warangal district. As a missionary, he supported the protest movements of the marginalized labourers for suitable daily wages and conducted free night schools for the illiterate people in villages. From 2017, he has utilized the barren land to start organic farming and promoted green homes, helped the community kitchen by providing agricultural products cultivated from parish property during the pandemic period, and gave leadership for supporting the families affected by floods in surrounding areas.

## Luyanda Hlatshwayo



Luyanda is a Reclaimer and an Implementation Officer at the African Reclaimers Organisation currently based in the City of Johannesburg.

As a reclaimer, Luyanda works to collect, sort, and sell recycled materials from most what we think is waste through their separation at source initiatives. His other functions at ARO include organising other reclaimers in different communities so that their voice and importance in society is realised.

Parthaa Bosu has two decades of experience working on vehicular emissions. He started his career at the Society of Indian Automobile Manufacturers (SIAM), where he was a part of the team that developed the computerized emission check system (PUC) for vehicles in India (which remains in use today). In 2010, he joined the UN Partnership, Clean Air Asia, as the India Representative, before becoming their India Director and South Asia Liaison. During his tenure, he gained importance for air pollution in India. He was a part of the working group on non-motorized transport promotion at the Ministry of Urban Development, Govt of India. He developed the world's first walkability survey app. He also structured the country's first and only Green Logistics Working Group with the Ministry of Heavy Industries and the NITI Aayoq. to reduce emissions and improve freight efficiency. He also launched the IndAIR repository of indigenous air quality studies with NEERI and CPCB. Currently, he is the lead India advisor to Environmental Defense Fund (EDF). In addition, he is directing the USAID funded Clean Air Catalyst, a multi-stakeholder consortium, working towards clean air in Indore and developing a protocol on hyperlocal hotspots in India.

Shayna Cohen

Shayna Cohen is the Community Outreach and Expansion Director of Repair the Sea/Tikkun HaYam. Since joining the organization's team as its first employee in 2018, she jointly grew a college club, Scubi Jew, into an international organization, expanded an annual local cleanup into a debris removal program in 18 countries, and coordinated the transition of over 50 campus organizations to 100% biodegradable dinnerware.
