

II. Annotations

- 1. The sixth session of the Meeting of the Parties to the Protocol on Water and Health to the Convention on the Protection and Use of Transboundary Watercourses and International Lakes (Water Convention) will be held from 16 to 18 November 2022, at the Palais des Nations, Geneva.
- 2. The meeting will comprise a high-level segment followed by a general segment. The high-level segment covers agenda items 1–3 and will be held in the morning and early afternoon of Wednesday, 16 November, starting at 10 a.m. The general segment addresses agenda items 4–21 and will start on Wednesday, 16 November, at 3.30 p.m. and will run until 5.30 p.m. on Friday, 18 November.
- 3. Remote participation in the meeting is possible, but in-person participation is strongly encouraged.
- 4. Relevant meeting documentation and practical information will be made available in due course on a dedicated page on the Protocol's website.¹

1. Opening of the session and adoption of the agenda

- 6. Thereafter, the Executive Secretary of the United Nations Economic Commission for Europe (ECE) and the World Health Organization (WHO) Regional Director for Europe will address the Meeting of the Parties.
- 7. The Meeting of the Parties is expected to adopt its agenda as set out in the present document.

8. The Chair will invite the Parties to take note of the document on procedural matters of relevance to decision-making at the sixth session of the Meeting of the Parties due to its hybrid format, and to decide to apply it during the session.

Procedural matters of relevance to decision-making at the sixth session of the Meeting of the Parties due to the hybrid format imposed by the circumstances associated with the coronavirus pandemic (ECE/MP.WH/2022/1-EUCHP/2219533/3.1/2022/MOP-6/07)

Organization of work (informal document)

2. High-level session: "The Protocol on Water and Health: strengthening the resilience of WASH and health services in times of climate change and pandemics"

Tentative timing: Wednesday, 16 November, 10.45 a.m.-1 p.m.

- 9. Global drivers such as climate change, population growth, urbanization and environmental pollution alter the availability and quality of freshwater resources and challenge access to safe and reliable water, sanitation and hygiene (WASH) services, exacerbating already-existing challenges. The coronavirus disease (COVID-19) pandemic, in particular, has shown how vulnerable WASH and health services can be and how important they are in taking response actions and in recovering from impacts.
- 10. The consequences of climate change, such as water quality changes, water scarcity, floods and sea-level rise, together with their social, economic and environmental impacts, are a rapidly emerging concern across the pan-European region that requires the urgent attention of policymakers, scientists and practitioners. The impact of these changes on WASH services and behaviours and on water resources is multifaceted and can have significant public health and environmental consequences, exacerbating the occurrence of water-related diseases and environmental degradation. Held in a hybrid format from 12 to 13 April 2022 in Geneva, the Pan-European Regional Preparatory Meeting for the United Nations 2023 Water Conference (New York, 22–24 March 2023) highlighted the urgent need for the region to further strengthen adaptation to climate change to accelerate progress in making drinking water and sanitation available, safe and affordable for all.
- 11. The COVID-19 pandemic has highlighted the critical role of WASH services as the first line of defence in preventing and controlling the spread of infectious diseases. World Health Assembly resolution 73.1 on COVID-19 response identified WASH as a central component, calling upon countries "to take measures to support access to safe water, sanitation and hygiene, and infection prevention and control, ensuring that adequate attention is paid to the promotion of personal hygienic measures in all settings, including humanitarian settings, and particularly in health facilities".²
- 12. These challenges require appropriate intersectoral and multi-stakeholder action among numerous relevant sectors, including health, environment and water, along with the joint development of strategies and recommendations to respond to them.
- 13. Through its multisectoral convening power, target setting and accountability framework, and various tools on offer, the Protocol on Water and Health can play an important role in building a better and fairer future following the pandemic, while addressing the effects of climate change.
- 14. In the last twenty years, the Protocol has supported remarkable progress in water, sanitation, hygiene and health across the region, particularly in providing access to safe and equitable drinking water and sanitation services, improving drinking water quality, reducing

the occurrence of water-related disease incidents and outbreaks, and sound water resource management. The Protocol continues to contribute to advancing and operationalizing the achievement of the 2030 Agenda for Sustainable Development in countries of the region, especially in the implementation of Sustainable Development Goals 3 (Ensure healthy lives and promote well-being for all at all ages) and 6 (Ensure availability and sustainable management of water and sanitation for all).

- 15. The Protocol can support the recovery process towards a more resilient post-pandemic world by placing access to essential services, such as universal and equitable access to safe and climate-resilient drinking water, sanitation and hygiene for all in all settings, centre stage. The Protocol also seeks to support policymakers in integrating adaptation to climate change impacts into water and sanitation policy and strategic planning, while helping water and sanitation service operators to effectively manage climate risks.
- 16. The high-level session will provide an opportunity to appraise progress and take stock of the concrete results of countries' responses to ensure access to water, sanitation, hygiene and health for all in the context of the pandemic and possible future pandemics. It will also foster an open dialogue on how to tackle the persisting gaps and challenges posed by climate change in the pan-European region to create climate-resilient WASH and health services.
- 17. The session will focus on the following questions:
- (a) What are the lessons learned from the pandemic and how can national and local WASH actions and policies be further prioritized to effectively respond to and recover from the pandemic and prevent future outbreaks, including to achieve Sustainable Development Goals 3 and 6?
- (b) How can immediate policy responses be taken to secure and extend WASH service provision in times of pandemics?
- (c) What WASH interventions should be prioritized in the context of the pandemic to better protect the health and well-being of the most vulnerable and marginalized populations?
- (d) How can national targets be set and action plans be developed under the Protocol to help countries respond to and recover from the pandemic?
- (e) How can the impacts of climate change on water, sanitation and health services in the pan-European region be effectively addressed with a view to achieving Sustainable Development Goals 6 and 13 (Take urgent action to combat climate change and its impacts)?
- (f) What policy and practical responses has your country taken to strengthen the resilience of water resources, water and sanitation facilities and services to the effects of climate change?
- (g) How can the Protocol framework and its tools further support countries to strengthen climate resilience in water management and in the WASH and health sectors?
- 18. A first keynote speech will set the scene by providing a landscape analysis of how the pandemic has affected the water, sanitation and health situation in the pan-European region and outlining how the Protocol frameworks can support countries to respond to and recover from the pandemic.
- 19. A second keynote speech will provide insights into the effects of climate change in the pan-European region and their impacts on water, sanitation and health services and sectors, and explore what opportunities exist at both the technical and political levels to address those impacts, including through the Protocol.
- 20. Following each keynote speech, a panel composed of high-level representatives from countries and international and non-governmental organizations will discuss priority issues related to the challenges posed by both the pandemic and climate change to WASH and health services and facilities. Additionally, panellists will discuss existing options, good practices and solutions to tackle these threats and impacts in the pan-European region, and will also be invited to reflect on the role of the Protocol in shaping the regional agenda on water, sanitation and health and in achieving the 2030 Agenda.

- 21. Subsequently, Parties, other States and stakeholders will be invited to participate in an interactive, moderated discussion on the above-mentioned issues. Interventions and statements should not exceed three minutes in length. To facilitate the running of the high-level session, delegations planning to make a statement are invited to inform the secretariat in advance.
- 22. The main outcomes of the session will be reflected in a summary of proposed actions and recommendations, which will be brought forward towards the United Nations 2023 Water Conference and inform the formulation of the declaration of the Seventh Ministerial Conference on Environment and Health (Budapest, July 2023).

3. Status of ratification of the Protocol and report on credentials

Tentative timing: Wednesday, 16 November, 3–3.30 p.m.

- 23. The joint secretariat of the Protocol will inform the Meeting of the Parties about the status of ratification of the Protocol on Water and Health.
- 24. Delegates from States or regional economic integration organizations not yet Parties to the Protocol will be invited to briefly present their plans to ratify, accept, approve or accede to the Protocol, or related progress.
- 25. In accordance with rule 15 of the rules of procedure for the meetings of the Parties to the Protocol (ECE/MP.WH/2/Add.1-EUR/06/5069385/1/Add.1), the Bureau will report on the credentials submitted by the Parties.³ Parties to the Protocol are therefore invited to inform the secretariat of the name(s) of their representative(s) at their earliest convenience, and to submit the credentials or a copy thereof to the ECE secretariat by 1 November 2022. Those Parties that have submitted a copy of the credentials should present the originals to the secretariat before the sixth session of the Meeting of the Parties, on arrival at the meeting in Geneva.

26. The Meeting of the Parties will first elect the Chair and Vice-Chairs of the sixth session. Subsequently, it will discuss the global and regional context for the activities carried out under the Protocol and will be informed about relevant processes on water, sanitation, hygiene and health. In the light of this, the Meeting of the Parties will review achievements under the current programme of work for 2020–2022 (ECE/MP.WH/19/Add.1-EUPCR/1814149/1.2/2019/MOP-5/06/Add.1), including in the context of the impacts of the pandemic, and examine proposals for activities under the programme of work for 2023–2025.

4. Elections of the Chair and Vice-Chairs of the sixth session of the Meeting of the Parties and other members of the Bureau

Tentative timing: Wednesday, 16 November, 3.30-3.50 p.m.

27. In accordance with rule 17 (1) and (2) of its rules of procedure, the Meeting of the Parties will elect a Chair and two Vice-Chairs. The Meeting of the Parties will then elect additional officers to serve as members of the Bureau. The Chair, Vice-Chairs and Bureau members will remain in office until the next elections at the seventh session of the Meeting of the Parties.

5. Global and regional context: relevant processes on water, sanitation, hygiene and health

Tentative timing: Wednesday, 16 November, 3.50-4.15 p.m.

- 28. The Meeting of the Parties will be informed about relevant global and regional processes and initiatives on water, sanitation, hygiene and health. In particular, participants will be informed about the preparations for the United Nations 2023 Water Conference and will discuss how the Protocol's implementation, including at country level, can support the objectives and expected outcomes of the Conference.
- 29. The secretariat will inform the Meeting of the Parties about the preparations leading to the Seventh Ministerial Conference on Environment and Health and how the outcomes of the Meeting of the Parties will inform the high-level commitments on environment and health to be adopted at the Conference.
- 30. The Meeting of the Parties will also be informed about the status of the implementation of the water-, sanitation- and hygiene-related targets of the Sustainable Development Goals.
- 31. A representative of the European Union will be invited to inform the Meeting of the Parties about the recast of the Drinking Water Directive⁴ and the Urban Wastewater Treatment Directive,⁵ as well as other relevant developments and possible synergies with work carried out under the Protocol.

6. Improving governance for water and health: support for setting targets and implementing measures

Tentative timing: Wednesday, 16 November, 4.15-5.30 p.m.

- 32. The Chair of the Task Force on Target Setting and Reporting will present the outcomes of the work of the Task Force in the past triennium.
- 33. With reference to article 6 (3) of the Protocol, countries that have achieved significant progress in setting, revising and/or implementing their targets in the period 2020–2022 will be invited to report on their efforts. Participants will discuss: the benefits and specific challenges encountered when setting, revising or implementing targets; and existing solutions; and lessons learned. Participants will also be invited to highlight how other programme areas under the Protocol have influenced target setting at the national and local levels.
- 34. Subsequently, the Meeting of the Parties will review the implementation of the Protocol on the basis of the national summary reports submitted by Parties during the fifth reporting cycle.⁶ In this respect, the joint secretariat will present the regional report on the status of implementation of the Protocol. The Meeting of the Parties will also take note of reports submitted by signatories and other States that are not Parties to the Protocol.
- 35. Participants will be invited to discuss the main trends, challenges and solutions emerging from the fifth reporting exercise of 2021–2022.
- 36. The lead Parties will introduce suggested future work in this programme area for the period 2023–2025. The Meeting of the Parties will discuss the proposed activities. Country delegates will also be invited to express interest in organizing national and/or subregional capacity-building events to support target setting and implementation in the forthcoming triennium.

7. Assistance to support accession and implementation at the national level

- 37. A representative of the ECE secretariat will inform Parties about the support for implementation of the Protocol at the national level provided by the ECE-led National Policy Dialogues on Integrated Water Resources Management and Water Supply and Sanitation under the EU4Environment Water Resources and Environmental Data programme and the European Union Water Initiative National Policy Dialogues in Central Asia project. The ECE secretariat will also report on other international projects promoting implementation of the Protocol at the national level.
- 38. A representative of the WHO Regional Office for Europe secretariat will brief participants on assistance provided to member States through the framework of biennial collaborative agreements and country cooperation strategies to support the Protocol's work.
- 39. The joint secretariat will introduce suggested future activities for the period 2023–2025. The Meeting of the Parties will discuss the proposed activities. Country delegates from

8. Increasing resilience to climate change

Tentative timing: Thursday, 17 November, 10-11 a.m.

- 40. The lead country will report on activities and progress made in the area of increasing resilience to climate change in the past triennium. In particular, the Meeting of the Parties will be informed about the development of the Background Note on Increasing Resilience to Climate Change through the Protocol on Water and Health, which provides an overview of how the Protocol's framework, areas of work and tools can support action to address climate-sensitive health and environmental risks.
- 41. Participants will also be informed about the outcomes of the Global workshop on building climate resilience through improving water management and sanitation at national and transboundary levels (Geneva (online), 29–31 March 2021), jointly organized with the Water Convention, and of the outcomes of the special session on climate change held during the thirteenth meeting of the Working Group on Water and Health (Geneva (hybrid), 19–20 May 2022).
- 42. The lead country will introduce suggested future work in this programme area for the period 2023–2025. The Meeting of the Parties will discuss the proposed activities. Country delegates will also be invited to express interest in organizing national, subregional and/or regional capacity-building events on increasing resilience to climate change in the forthcoming triennium.

- 43. The Chair of the Compliance Committee under the Protocol will report on the Committee's activities in the past triennium. In particular, he will report on the outcomes of the review of compliance with the obligation to set targets and target dates under article 6 of the Protocol; and the Consultation Process.
- 44. The Meeting of the Parties will be invited to take note of the Committee's report, including any general recommendations contained therein, and to consider, revise as necessary and adopt a draft decision on general issues of compliance, prepared by the Committee.
- 45. Parties will be invited to express interest in undertaking a consultation with the Committee under the Consultation Process in the period 2023–2025 as part of the future programme of work.
- 46. The Meeting of the Parties is expected to elect six members of the Compliance Committee, in accordance with the procedure set out in the annex to decision I/2 on the review of compliance (ECE/MP.WH/2/Add.3–EUR/06/5069385/1/Add.3).

10. Prevention and reduction of water-related diseases

Tentative timing: Thursday, 17 November, noon–1 p.m.

- 47. The lead Parties will report on activities and progress made in the area of prevention and reduction of water-related diseases in the past triennium. In particular, the Meeting of the Parties will be informed about the development of two training modules: (a) Surveillance and outbreak management of water-related infectious diseases associated with water-supply systems; and (b) Surveillance of drinking water using risk-based approaches. The Meeting of the Parties will be invited to endorse these training materials for use in capacity-building activities.
- 48. The Meeting of the Parties will be briefed on the outcomes of the Expert meeting on prevention and control of legionellosis in the pan-European region (online, 30 November–2 December 2021), including supporting activities focusing on the burden of legionellosis in the region and existing regulatory frameworks.
- 49. A representative of the WHO Regional Office for Europe secretariat will report on the utility of surveillance of severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2) in wastewater in the context of managing the COVID-19 pandemic, including the development of an interim guidance document and associated questions and answers. Participants will be invited to share their experiences in setting up and implementing environmental surveillance programmes for SARS-CoV-2.
- 50. Representatives of Parties and other States will be invited to report on activities towards strengthening water-related disease surveillance and outbreak response systems at the national and local levels in accordance with article 8 of the Protocol, including their experiences in using the practical tools developed under the Protocol: Strengthening surveillance and outbreak management of water-related infectious diseases associated with water supply systems⁷ and Strengthening drinking water surveillance using risk-based approaches.⁸
- 51. The lead Parties will introduce suggested future work in this programme area for the period 2023–2025. The Meeting of the Parties will discuss the proposed activities. Country delegates will also be invited to express interest in organizing national or subregional capacity-building events on water-related disease and/or water quality surveillance in the forthcoming triennium.

11. Institutional water, sanitation and hygiene

Tentative timing: Thursday, 17 November, 3-4 p.m.

- 52. The lead Parties will report on activities and progress made in the area of water, sanitation and hygiene in schools and health-care facilities in the past triennium. In particular, the Meeting of the Parties will be informed about the outcomes of the two editions of the Subregional workshop on water, sanitation and hygiene (WASH) in schools (online, 6–8 July 2021 and 4–6 April 2022), as well as the objectives and key contents of the two following publications: (a) *Improving quality of care through better water, sanitation and hygiene: A pan-European perspective*; and (b) *Water, sanitation and hygiene in health-care facilities: A practical tool for situation assessment and improvement planning*. The Meeting of the Parties will be invited to endorse these publications.
- 53. The Meeting of the Parties will be briefed on the progress of implementation of World Health Assembly resolution 72.7 on water, sanitation and hygiene in health-care facilities, specifically the outcomes of national assessments undertaken in Georgia, Hungary, Montenegro, Serbia and Tajikistan.
- 54. Representatives of Parties and other States will be invited to report on national activities on water, sanitation and hygiene in schools and health-care facilities, including on the setting and implementation of targets and on experiences in using the practical tools developed under the Protocol to improve surveillance and management of water, sanitation and hygiene in schools. Participants will also be invited to report on particular measures taken in schools and health-care facilities in the context of the pandemic and World Health Assembly resolution 73.1 on COVID-19 response.
- 55. The lead Parties will introduce suggested future work in this programme area for the period 2023–2025. The Meeting of the Parties will discuss the proposed activities. Country delegates will also be invited to express interest in organizing national or subregional capacity-building events on water, sanitation and hygiene in schools and health-care facilities in the forthcoming triennium.

- 56. The lead Parties will report on activities and progress made in the area of small-scale water supplies and sanitation in the past triennium. In particular, the Meeting of the Parties will be briefed on the main findings of the review of targets and country activities on small-scale water supply and sanitation systems, summarized in the report *Small-scale water supply and sanitation systems: Country activities towards achieving safe services*.
- 57. The Meeting of the Parties will be informed about the objectives and key contents of the publication *A field guide to improving small drinking water supplies: Water safety planning for rural communities*, which provides a practical tool to support the adoption of water safety plans in small-scale systems. The Meeting of the Parties will be invited to endorse the document.
- 58. Representatives of Parties and other States will also be invited to share experiences on water safety plan uptake in small systems and provide information on national activities and policy developments to improve small-scale water supply and sanitation, including progress regarding a field project to implement integrated water safety and sanitation safety plans in Serbia.
- 59. The lead Parties will introduce suggested future work in this programme area for the period 2023–2025. The Meeting of the Parties will discuss the proposed activities. Country delegates will also be invited to express interest in organizing national or subregional capacity-building events on small-scale water supply and sanitation in the forthcoming triennium.

- 60. The lead Parties will report on activities and progress made in the area of safe and efficient management of water supply and sanitation systems in the past triennium. In particular, the Meeting of the Parties will be briefed on the outcomes of the two online Expert consultations on on-site sanitation in the pan-European region held, respectively, on 5–7 October 2021 and 24 June 2022.
- 61. The Meeting of the Parties will be informed about the publication *Delivering safe sanitation for all: Areas for action to improve the situation in the pan-European region*, aimed at presenting available evidence regarding the status of sanitation in the pan-European region and the challenges and opportunities in the sanitation sector, and recommending priorities for policy attention and action. The Meeting of the Parties will be invited to endorse the publication *Delivering safe sanitation for all: Areas for action to improve the situation in the pan-European region*.
- 62. Representatives of Parties and other States will be invited to provide information on national activities and policy developments relating to the implementation of water safety and sanitation safety planning approaches, including uptake in national legislation and/or setting dedicated targets under the Protocol. Participants will also be invited to report on the implications of the pandemic for the provision of water supply and sanitation services and specific measures taken to ensure continued and safe operation of such systems.

63. The lead Parties will introduce suggested future work in this programme area for the period 2023–2025. The Meeting of the Parties will discuss the proposed activities. Country delegates will also be invited to express interest in organizing national or subregional capacity-building events on water and sanitation safety planning and/or sanitation regulations in the forthcoming triennium.

14. Equitable access to water and sanitation: translating the human rights to water and sanitation into practice

- 64. The lead Parties will report on activities and progress made in the area of equitable access to water and sanitation in the past triennium, including the outcomes of the work of the Sixth Meeting of the Expert Group on Equitable Access to Water and Sanitation (online, 24–25 March 2021) and the Regional Workshop on Equitable Access to Water and Sanitation: New policy developments, impacts of COVID-19 and options to ensure affordability (Geneva (hybrid), 13–14 June 2022).
- 65. The Meeting of the Parties will also be informed about the publication *Making water* and sanitation affordable for all: Policy options and good practices to ensure the affordability of safe drinking water and sanitation services in the pan-European region, which unpacks the concept of affordability of water and sanitation services and identifies and analyses different policy options to address affordability concerns. The Meeting of the Parties will be invited to endorse this publication and to discuss how to promote its use.
- 66. Representatives of Parties and non-Parties that have applied *The Equitable Access Score-card: Supporting policy processes to achieve the human right to water and sanitation*¹⁰ and the *Guidance Note on the Development of Action Plans to Ensure Equitable Access to Water and Sanitation*¹¹ will report on progress made in assessing the equity of access to water and sanitation and implementing actions to improve equitable access.
- 67. The lead parties will introduce suggested future work in this programme area for the period 2023–2025. The Meeting of the Parties will discuss the proposed activities. Country delegates will also be invited to express interest in the application of the Protocol tools on equity during the forthcoming triennium.

15. Financing of the Protocol on Water and Health

Tentative timing: Friday, 18 November, 10.30 a.m.-noon

68. The financing of the Protocol on Water and Health largely relies on voluntary contributions. While there has been a positive development since the last session of the Meeting of the Parties, with more Parties contributing to both ECE and WHO Protocol trust funds, the overall financial situation remains very challenging. A specific round table

discussion on financing will be organized with Parties to the Protocol, focusing on the resources needed to ensure the reliable and successful implementation of the Protocol.

- 69. The round table discussion will start with the joint secretariat setting the scene by presenting the overview of financing needs and contributions received since the Protocol entered into force in 2005, highlighting challenges faced with respect to the lack of resources as well as good practices by Parties. The joint secretariat will also provide an overview of the financial resources made available for the implementation of the programme of work for 2020–2022, and will introduce the overview of resource requirements for 2023–2025.
- 70. The Meeting of the Parties will be invited to discuss the situation regarding staff resources in the ECE and WHO/Europe parts of the joint secretariat. In this regard, the meeting will be informed about the outcome of its request from the fifth session (Belgrade, 19–21 November 2019) to the Secretary-General of the United Nations to provide additional regular budget resources for ECE secretariat staff.¹²
- 71. Subsequently, Parties will be invited to make short interventions on the financial contributions that they could provide in order to support implementation of the programme of work for 2023–2025, as well as how they could support efforts to enhance the sustainability and predictability of financing under the Protocol, based on the following guiding questions:
- (a) What financial contribution can your country make in order to support implementation of the programme of work for 2023–2025 (e.g., funding from the competent authorities represented by the Protocol focal points, other national entities, including ministries of foreign affairs and development cooperation agencies, and/or other sources)?
- (b) As a Party, how can your country support efforts to enhance the sustainability and predictability of financing under the Protocol?
- (c) How can your country contribute in kind to the Protocol's activities (for example, by planning and implementing activities foreseen under the programme of work for 2023–2025, hosting meetings, including travel for participants and logistical meeting arrangements, or supporting the production of publications)?
- 72. During the round table discussion, all Parties will be invited to reply to these questions. Representatives of other States, relevant international and non-governmental organizations and other partners may also take the floor.
