I. About the National Urban Forum

Context

Lebanon is one of the most urbanized countries in both the Arab region and the world, with around 89 per cent of its population living in urban areas. For decades, the country has witnessed rapid and uncontrolled urban growth and sprawl. With limited planning regulations in place or enforced, built-up areas are expanding to cover increasingly larger spaces, while at the same time, urban disparities have grown and continue to do so. The lack of local planning and cross-sectoral master plans hinders any absorption capacity of the increasing urban population and its social, economic, environmental and demographic needs.

The multiple crises the country has been facing in the past years – including the protracted Syrian refugee crisis, the worsening and dire socioeconomic situation, the ongoing and crippling energy crisis, the COVID-19 pandemic, the political instability, and financial collapse – have placed huge additional pressure on already poorly served urban areas, resulting in increased poverty, widening inequalities, and heightened social tensions. With the ongoing crises, persons with vulnerabilities are increasingly marginalized and at risk in the urban context. The public social infrastructure is weak, social protection is fragmented, and social services have declined with the ongoing crises, raising concerns, particularly in urban areas. The compounded crises have also vastly affected the already weak provision of adequate and affordable housing as well as basic urban services and infrastructure, including electricity and transport, among others. These in turn contribute to increased instances of discrimination, exclusion and violence, as well as feelings of insecurity and unsafety, especially among the most vulnerable segments of the population.

To effectively address many of these challenges in a sustainable manner, there is a need to have a better understanding of their complexities and their interlinkages in urban settings, placing sustainable urban development as a key element in the forthcoming United Nations Sustainable Development Cooperation Framework (UNSDCF) for Lebanon, and of national policy and planning discourse at large – including at the level of the national government in terms of planning for a future more prosperous and sustainable Lebanon. To reinstate this discourse and evidence base, UN-Habitat has partnered with the United Nations Economic and Social Commission for West Asia (ESCWA) to produce a *State of the Lebanese Cities Report*, with planned publication in early 2022.

Furthermore, and as part of a National Urban Policy (NUP) Programme launched by UN-Habitat in the Arab region in 2017, the NUP diagnosis phase was completed for Lebanon in 2018, with the publication of a diagnosis report. As part of this phase, two sectors – housing and transport – were highlighted as priority areas in need of policy reforms. Leading into the NUP formulation phase, UN-Habitat Lebanon has completed three reports on these sectors, which will be launched during the first National Urban Forum (NUF1). In order to ensure inclusivity of relevant urban actors in the next phases of the NUP process, and in the absence of a high-level governmental body that deals with urban issues in an integrated manner, there is a need to create opportunities for genuine dialogue and consultations with all relevant stakeholders.

Objectives

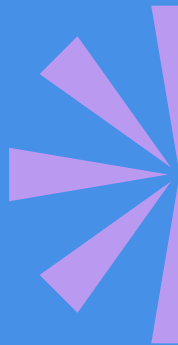
The overall objective of this first NUF in Lebanon is to concretely discuss the increasing urban challenges, considering the multiple ongoing crises in Lebanon – including how unplanned and poor urbanization has contributed to the daily struggles of communities across the country – and articulate why an urban lens is indispensable to contributing to finding evidence-based solutions out of the current complexities, and to fostering a sustainable and prosperous Lebanon, ensuring inclusiveness of vulnerable groups who often risk falling behind.

This is not only because cities are simply where a rising majority of people live but also because well-managed urbanization has the potential to lift people out of poverty and address their basic needs – including housing, energy, transport, water and more.

Within this overall objective, NUF1 in Lebanon is specifically aimed to:

- Increase **understanding of the state of urbanization** in Lebanon at national and subnational levels and how this has contributed to the current demise of cities – and how solutions can be borne – towards transforming Lebanese cities for a better urban future. *The State of the Lebanese Cities Report* will provide a basis for discussion.
- Increase **understanding of the needs of those most vulnerable in urban settings**, including women, youth, and persons with disabilities.
- Improve **advocacy for urbanization that is well-managed**, including through evidence-based national urban policies, as a route to sustainable development – with a specific focus on housing and transport as critical entry points to a socioeconomically viable and inclusive Lebanon.
- **Take stock of the pre-existing and unfolding energy crisis** in Lebanon, with a focus on identifying sustainable solutions for large-scale renewable energy use in urban environments and transportation.

II. NUF1 Programme



The NUF1 is a two-day event that will take place in Beirut on 23–24 March 2022.

Day 1

Wednesday, 23 March 2022

Location: UN House ESCWA (Conference Hall), Beirut

About

The first forum day is focused on positioning the event's themes within the current political, policy and institutional landscape of the country. Following the opening of the forum, a plenary session will be held, where the current state of urbanization will be presented, launching the *State of the Lebanese Cities Report* prepared by UN-Habitat Lebanon in partnership with ESCWA. It is envisaged that the report will not only contribute specialist input into the United Nations Common Country Analysis (CCA) and subsequently the UNSDCF, but more widely will inform and help guide the efforts of national entities currently or potentially engaged in sustainable urban development, particularly city municipalities, unions of municipalities, and national government elements.

Underpinning and immediately following the launch of the *State of the Lebanese Cities Report*, a dedicated technical session will be held focused on unpacking the significance of urban data generation and evidence-led decision-making for urban crisis response and longer-term development of Lebanese cities, the lack of urban data, and the key role of such data towards building resiliency.

About

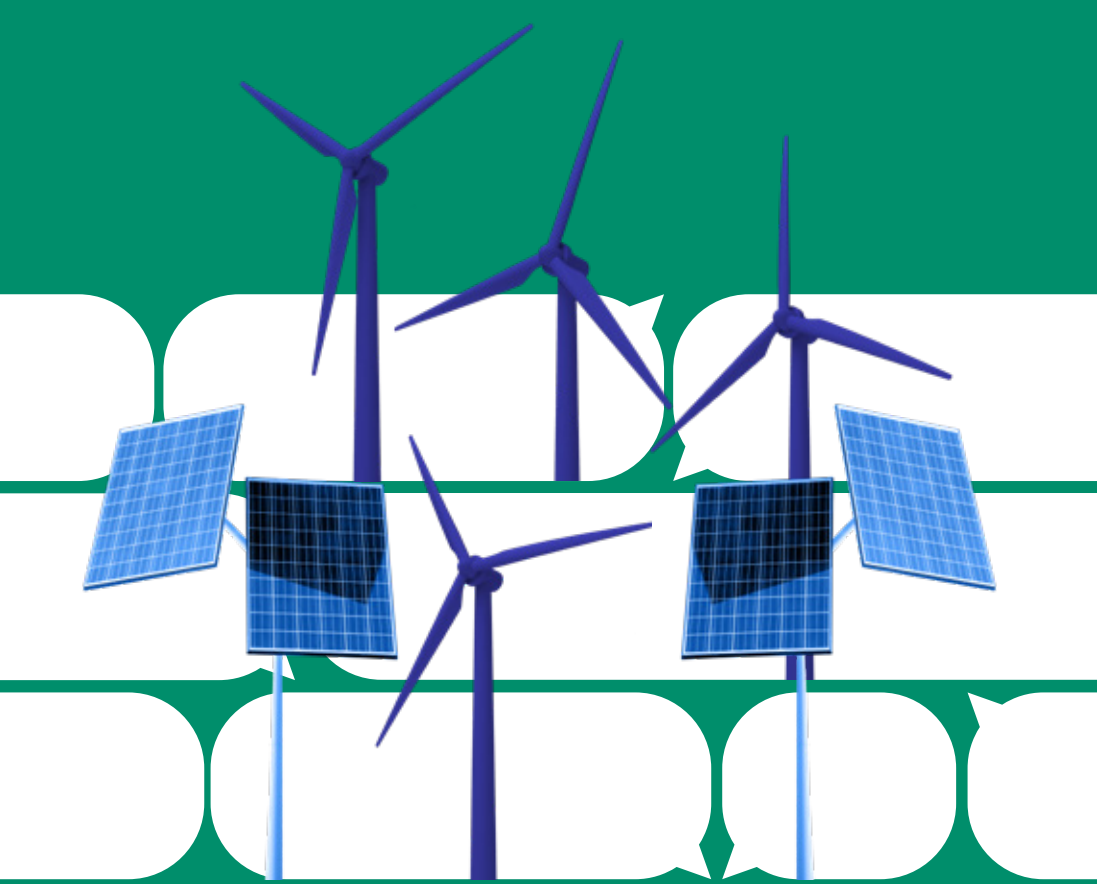
Session III: Towards the development of an inclusive national housing policy

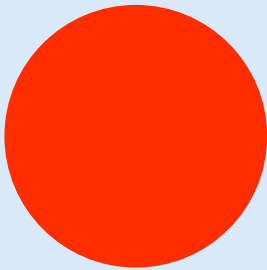
