THE POWER OF A PEOPLE-CENTERED APPROACH, PARTNERSHIPS, AND INTEGRATION OF THE HIV RESPONSE INTO UHC TO END AIDS BY **2030**: LESSONS LEARNED FROM THE AIDS RESPONSE

BACKGROUND

Thailand, as chair of the 2022 UNAIDS Programme Coordinating Board (PCB), is honored that the 51st PCB will be hosted in Chiang Mai, Thailand. The country notes that this is the first time in 14 years that the PCB meeting will be held outside Geneva.

As part of the 51st UNAIDS PCB meeting, the Thai Government, together with national partners at all levels, is very pleased to organize the **2022 UNAIDS PCB Field Visit** from 12-13 December 2022. This is a great opportunity for board members to experience programmatic implementation and the human-touch while interacting with frontline implementers, communities and people infected with and affected by HIV. Moreover, the planned field visits are directly related to the issues to be discussed at the 51st UNAIDS PCB meetings.

Thailand has the fourth-highest HIV burden based on the number of people living with HIV (PLHIV) in Asia and the Pacific. In 2021, there were an estimated 520,000 PLHIV and 6,500 new HIV infections in Thailand. The number of new HIV infections has declined by 59% since 2010, reflecting the progress that Thailand has made in recent years. The total estimated AIDS-related deaths were 9,300 in 2021. The number of AIDS deaths has declined by 66% since 2010, with 447,061 PLHIV on ART. Thailand's HIV epidemic is concentrated among key populations, with those most affected being men who have sex with men (MSM), sex workers (SW), transgender people (TG), migrants, prisoners, and people who inject drugs (PWID).

Over nearly four decades, Thailand has demonstrated tremendous progress in its HIV/AIDS program and has been recognized for its regional and global leadership around several innovations in its quest to end AIDS. Throughout 2022 the Thai Government has collaborated with UNAIDS¹ and other partners around key agendas. The first was on Zero Discrimination Day (1st of March) to promote action to eliminate all forms of HIV-related stigma and discrimination. The most recent partnership was with the Ministries of Public Health and Foreign Affairs from 20-21 October 2022 at the "2nd Asia-Pacific Youth Forum: "Putting Young Key Populations First to End AIDS by 2030". Held in Bangkok, this regional meeting fostered collaboration and partnerships for multi-stakeholder commitment and actions to strengthen HIV programming for and with young people and young key populations.

December 12th is International UHC Day. The Thai government, including the Ministry of Public Health, the National Health Security Office and the Ministry of Foreign Affairs, will collaborate with affected communities, PEPFAR, FHI360, the Global Fund, the UN Joint Team on AIDS, and UNAIDS to organize the 2022 UNAIDS PCB field visits under the theme "THE POWER OF A PEOPLE-CENTERED APPROACH, PARTNERSHIPS, AND INTEGRATION OF THE HIV RESPONSE INTO UHC TO END AIDS BY 2030: LESSONS LEARNED FROM THE AIDS RESPONSE".

OBJECTIVES

1. To demonstrate the practical actions and results/lessons learned of a resource-limited country that has adopted a people-centered approach, forged partnerships with people living with and affected by HIV, and integrated HIV and other health issues under Universal Health Coverage (UHC) and showcase the role of the UNAIDS Joint Programme as well as key partners including PEPFAR and FHI.

2. To inspire and boost determination among country leaders to accelerate progress toward ending AIDS by 2030.

3. To exchange lessons learned and showcase good practices:

- Lessons learned from the AIDS response in Thailand and the power of integration of HIV and health services in UHC Achieving the 95-95-95 targets and prevention targets through UHC, with community-led health services as part of the health system.
- **The power of a people-centered approach** Accelerating progress through communityand key population-led health services and response.
- **The power of partnerships** Linking HIV services between the community and health services and achieving the 10-10-10 targets through the Thailand Partnership for Zero Discrimination initiative by promoting a multisectoral approach to eliminate all forms of HIV-related stigma and discrimination.

FIELD VISIT OPTIONS

The various sites for the field visits have been reviewed and selected by the working group, led by the Thai Ministry of Public Health.

The field visits will provide an opportunity for the PCB members to observe Community-Led Health Services (CLHS), and Key Population-Led Health Services (KPLHS) for MSM, TG, SW, people who use drugs (PWUD) including PWID, and young Key Populations. The site visits will also showcase the strong partnership of community and health facilities and the multisectoral approach, including through the support of the Joint Programme as well as key partners PEPFAR and FHI, for zero discrimination in action,.

All sites

Thailand is a resource-limited country but has been recognized as one of the leading nations in the Asia and Pacific region and globally to have effectively integrated HIV services into UHC, not only for treatment of all PLHIV, but also prevention and health promotion. Recently, at the 50th PCB in June 2022, the Thai UHC reached new heights by announcing its plan to formally fund CLHS as a part of the national public health service. This also means that participating CBOs will be directly reimbursed by the UHC system for services rendered to PLHIV and Key Populations. This is indeed a milestone toward the goal of supporting sustainable community-led health service delivery and sustainable financing for CBOs.

M-Plus and CAREMAT, Sanpatong and Saraphi Hospital

KPLHS is a people-centered service that demonstrates task-shifting to lay providers who are members of the Key Population communities themselves. The KPLHS providers have been trained to deliver high quality HIV and health services based on actual needs, in a way that is client-centered and stigma-free. Moreover, KPLHS providers are strengthened through in-service training, mentoring, and supervision. There is a national Community Health Worker certification and CSO accreditation system to provide HIV, STI, TB, HBV, and HCV screening, pre- and post-exposure prophylaxis (PrEP/PEP), dispense treatment via telemedicine, and serve as a link to referral hospitals. KPLHS has significantly contributed to national prevention coverage, and early HIV diagnosis and treatment.

Thai Drug users' Network (TDN), Thanyarak Hospital

Thailand has prioritized equitable and equal access to Harm Reduction and HIV prevention, testing and treatment for PWDU, PWID, and prisoners. The strategy is to leverage innovations such as virtual interventions, HIV self-testing, integrated community-based testing, diagnosis and treatment of HIV, HBV and HCV, counseling and mental health support, and linking the local services with the drug treatment hospital.

Chiang Mai Women Correctional Institution

An integrated HIV/TB programme has been implemented in prisons which combines routine HIV prevention, HIV testing, TB testing, and Cheat X-ray. Prisoners living with HIV and TB are referred for treatment to nearby hospitals. Moreover, there is a plan for follow-up after a prisoner is released, and this is coordinated with an appropriate CBO.

PLHIV groups at Ban-Hua-Rin Health Promoting Hospital

HIV-related stigma and discrimination remain an enormous obstacle to achieving the Ending AIDS goal. The Thai Government is determined to overcome this challenge and has become a member of the Global Partnership for Action to eliminate all forms of HIV-related stigma and discrimination across 6 settings including health care, education, workplace, community, justice, and humanitarian sectors. At the site, board members will have an opportunity to explore community engagement in reducing stigma and discrimination in the healthcare setting, including CLHS, implementing U=U as a stigma-reduction tool, and the community-led crisis response system for reporting human rights violations and supporting survivors.
