Context

Why Now?

Language technologies have made rapid progress in the recent years

Increase of virtual meetings and conferences

New technologies are creating new services

Users expect to be able **to use new technologies** in their daily work

Concrete demand in the European Commission to include speech services in the IT environment



Main benefits

Accessibility and Inclusiveness – in particular for the hearing impaired


Reaching a **larger audience** through recordings with subtitles

Efficiency in meetings (e.g. easier to take minutes, and to find back information from meetings)

Communication: it becomes easier to search for video content

Further analysis (AI/data technologies) becomes possible, such as automatic summary of the meetings

Beyond transcripts

Demands for post-processing of the transcripts after the event:

- Verbatim reports
- Meeting summary / automatic minutes
- Keywords extraction
- Sentiment analysis
- Automatic translation
- Speech synthesis
- Subtitles






Training of Custom Models

- ✓ Resources
 - ✓ Textual
 - ✓ Surgical: Corrections of mistakes observed during data validation
 - ✓ Best guesses:
 - ✓ Interviews, current news, named entities
 - ✓ Pronunciation
 - ✓ Corrections:

Correction	Observed error	
varhelyi	vahali	
varhelyi	verhelle	

- ✓ Abbreviations, CamelCase words, alphanumeric words
- ✓ Audio (respeak + speech produced with synthetic voice)
 - ✓ Names of commissioners, EU institutions and buildings, meeting rooms

- ✓ Testing and evaluation
 - ✓ Side-by-side verification

 - ✓ New names, terminology
 - ✓ Türkiye vs Turkey
 - ✓ Identifying bugs and getting them fixed



Synthetic Speech

E-Loqui: Convert text to eloquent speech



E-Loqui: platform for voiceover generation

- ✓ Development of a pilot
 - ✓ create voiceovers in all EU official languages + accession countries languages
 - ✓ for conference video content, e-Learning etc.
 - ✓ Predefined settings (character-voice association, pitch, rate, etc.)
 - ✓ Speech experts
 - ✓ Secure login, track usage, history of team projects (workspaces)
- ✓ Customs and Tax EU portal
