

#### **Annotations**

#### 1. Opening of the session, adoption of the agenda and other organizational matters

The Chairperson of the Executive Committee will open the seventy-fifth session of the Executive Committee of the Programme of the United Nations High Commissioner for Refugees on Monday, 14 October 2024, at 10:00 a.m. Central European Time.

The Executive Committee will consider the provisional agenda contained herein as the basis for adoption of the agenda of the session.

#### 2. Statement by the United Nations High Commissioner for Refugees

In his statement, the High Commissioner will provide an overview of the operational and policy priorities of the Office of the United Nations High Commissioner for Refugees (UNHCR).

#### 3. High-level segment on statelessness and general debate

Following the statement by the High Commissioner, the session will feature a high-level segment on statelessness to mark the end of the #IBelong campaign and to take stock of the campaign's achievements and good practices. The high-level segment on statelessness will also mark the launch of the Global Alliance to End Statelessness and provide an opportunity to renew collective commitments.

The general debate is articulated around issues raised in the statement of the High Commissioner. The Executive Committee will have received an outline of the statement in advance of the session. The Committee will also have before it brief updates on developments at the regional and global levels.

The list of speakers for the general debate will be opened on Monday, 16 September 2024.

#### 4. Consideration of reports of the Standing Committee

The Executive Committee will review the reports of the Standing Committee on international protection and on programme budgets, management, financial control and administrative oversight.

## (a) International protection

The Executive Committee will have before it the note of the High Commissioner on international protection (A/AC.96/75/3) and the reports of the Standing Committee on its eighty-ninth and ninetieth meetings (A/AC.96/75/2 and A/AC.96/75/10).

# (b) Programme budgets, management, financial control and administrative oversight

The Executive Committee will have before it the reports of the Standing Committee on its eighty-ninth, ninetieth and ninety-first meetings (A/AC.96/75/2, A/AC.96/75/10 and A/AC.96/75/11), the financial statements for the year 2023 as contained in the report of the Board of Auditors to the General Assembly on the financial report and audited financial statements of the voluntary funds administered by the High Commissioner for the year ended 31 December 2023 (A/AC.96/75/4), the report of the High Commissioner on key issues and measures taken in response to the report of the Board of Auditors for 2023 (A/AC.96/75/4/Add.1) and the report of the Office of Internal Oversight Services on the internal audit in UNHCR for the period from 1 July 2023 to 30 June 2024 (A/AC.96/75/7).

The Executive Committee will also have before it requests from observers for participation in future intersessional meetings of the Standing Committee.
