2. Policy perspectives on building an inclusive and sustainable digital future for accelerated implementation of the Sustainable Development Goals

Policy perspectives on building an inclusive and sustainable digital future for accelerated implementation of the Sustainable Development Goals (ESCAP/MCDIT/2)

Annotation

Accelerating progress towards the implementation of the 2030 Agenda for Sustainable Development is a priority in Asia and the Pacific, and innovations in digital technology applications are emerging as a powerful means of implementation. In the document, the secretariat discusses the role of digital transformation in building an inclusive and sustainable future in the context of the 2030 Agenda. It also provides a summary of the key findings contained in the *Asia-Pacific Digital Transformation Report 2024*. The digital transformation framework developed by the secretariat was used in the preparation of the report to introduce a hypothesis on the nexus between digital transformation, growth and climate change and to identify emerging good practices. Furthermore, the secretariat proposes policy recommendations aimed at strengthening regional cooperation on digital transformation in support of accelerated implementation of the Sustainable Development Goals.

The participants in the Ministerial Conference may wish to provide the secretariat with guidance on its policy recommendations regarding regional cooperation on digital transformation. Following the presentations given by the secretariat, a panel of experts consisting of government officials and representatives of academia and the private sector will discuss the findings presented in the document and make recommendations related to promoting digital transformation and sustainable development in Asia and the Pacific.

3. Digital solutions for sustainable development

Documentation

Digital solutions for sustainable development in Asia and the Pacific (ESCAP/MCDIT/3)

Annotation

In the document, the secretariat highlights experiences and good practices in adopting digital solutions for sustainable development in the Asia-Pacific region and discusses policy recommendations for promoting digital solutions. In line with resolution 80/1, in which the Commission noted with appreciation the initiative of the Government of Kazakhstan on establishing a digital solutions centre for sustainable development to provide practical digital solutions in Central Asia and beyond, the secretariat recommends the establishment of an ad hoc working group for members and associate members of the Commission to further study and discuss the modalities of establishing a digital solutions centre for sustainable development.

The participants in the Ministerial Conference may wish to discuss the issues presented in the document and provide guidance on the future work of the secretariat in that regard.

4. Strengthening regional digital cooperation for sustainable development

Progress made in strengthening regional digital cooperation in Asia and the Pacific (ESCAP/MCDIT/4)

Annotaation

In its resolution 80/1, the Commission encouraged all its members and associate members to strengthen regional and multi-stakeholder cooperation and to work together closely for the promotion of research and development in digital technologies and the fostering of human development and a culture of innovation and entrepreneurship with a view to expediting the implementation of the 2030 Agenda, in accordance with their national laws and priorities. In its document on progress made in regional digital cooperation, the secretariat discusses global and regional initiatives, notably progress made in the implementation of the Action Plan for Implementing the Asia-Pacific Information Superhighway Initiative, 2022–2026, which is aimed at strengthening digital cooperation for sustainable development. The secretariat also proposes policy recommendations on digital regional cooperation for Asia-Pacific countries.

The participants in the Ministerial Conference may wish to discuss the issues presented in the document and provide further guidance to the secretariat on strengthening regional digital cooperation, notably through the implementation of the Action Plan for Implementing the Asia-Pacific Information Superhighway Initiative, 2022–2026, in support of international cooperation.
