The proposal is complemented by an informal document proposing amendments to UN Regulation No. 130 for the same purpose.

GRVA agreed to resume discussion on the proposal for amendments to UN Regulations Nos. 13 and 13-H, prepared by the experts from the International Motor Vehicle Inspection Committee (CITA), aimed to enabling the live recording of brake demand values during Periodic Technical Inspections (PTI).
