2. Initiatives in climate change impact assessment and adaptation for inland transport

GE.3 is expected to continue its discussion on initiatives in climate change impact assessment and adaptation for inland transport. In this regard, experts may provide updates on ongoing initiatives as appropriate.

Under this item, lead authors for the chapters of the final technical report will present the updated drafts:

- ECE/TRANS/WP.5/GE.3/2025/4 on Transport Hazards from Climate Variability and Change: Recent Trends and Regional Modelling Projections
- ECE/TRANS/WP.5/GE.3/2025/5 on Policies and legislation for acting on adaptation of climate change in transport.
- ECE/TRANS/WP.5/GE.3/2025/6 on Methodologies for assessing impacts of climate change hazards on transport systems.
- ECE/TRANS/WP.5/GE.3/2025/7 on Effective adaptation of transport systems and assets to the changing climate.

GE.3 will be expected to finalise these chapters for inclusion in the final report.

The Chair and Vice-chair with support of the secretariat will present the draft chapter with introduction to the final report and the draft chapter on conclusions and recommendations for GE.3 consideration and finalisation. Informal document WP.5/GE3 (2025) No. 22 and Informal document WP.5/GE3 (2025) No. 23 contain respectively these draft chapters.

GE.3 will be then expected to endorse case studies reviewed at previous session for inclusion in the final report. ECE/TRANS/WP.5/GE.3/2025/8 contains case studies on application of risk assessment methodologies. ECE/TRANS/WP.5/GE.3/2025/9 provides case studies on climate impact assessment. ECE/TRANS/WP.5/GE.3/2025/10 presents case studies on application of adaptation measures in transport, and ECE/TRANS/WP.5/GE.3/2025/11 contains case studies on lessons learned from past events.

GE.3 will be also invited to review additional case studies submitted by experts. Informal documents WP.5/GE3 (2025) No. 24 through 35 present these additional case studies.

Subsequently, the Chair and Vice-chair will present the draft summary report for policy makers as contained in Informal documents WP.5/GE3 (2025) No. 36. GE.3 will be invited to consider and finalise it.

GE.3 will be invited to endorse its final report for submission to its parent body, the Working Party on Transport Trends and Economics (WP.5) for adoption.

Finally, the Chair and the Vice-chair with the support of the secretariat will introduce the draft terms of reference for a technical body to lead the future work on climate change assessment and adaptation in transport. Informal documents WP.5/GE3 (2025) No. 37 contains the draft terms of reference.

GE.3 upon consideration and finalisation of the terms of reference, will be requested to endorse them for submission to its parent body for adoption.

GE.3 may wish to explore potential future projects on application of stress tests.

The TER project manager will report on the TER workshop on resilience of railway assets to climate change.

GE.3 will be then invited to review the draft guide for assessing transport asset criticality developed further to comments made at the twenty-eight session. Informal document WP.5/GE.3 (2025) No. 38 contains the updated draft guide.
