II. Annotations to the provisional agenda

Item 1. Adoption of the agenda

1. The Working Party will adopt the agenda of its ninth session.

Item 2. Policy discussion: Implementing Public-Private Partnerships and resilient infrastructure for a sustainable future

- 2. Under this agenda item, member States will have the opportunity to explore how Public-Private Partnerships (PPPs) and resilient infrastructure can contribute to a sustainable future. More concretely, the policy discussion will explore best practices and strategies for integrating resilience and mobilizing sustainable and innovative finance, while leveraging artificial intelligence (AI) in PPP and infrastructure projects.
- 3. The policy discussion also contributes to the cross-cutting theme of the 71st session of the Economic Commission for Europe (ECE) in April 2025, and it will be structured in separate panels,² as well as the first Meeting for Government Delegates, as follows:

A. Panel 1: Scaling up sustainable and innovative finance for Public-Private Partnerships and infrastructure projects

4. Mobilizing sustainable and innovative finance is critical to bridging the infrastructure investment gap and advancing the Sustainable Development Goals (SDGs) through PPPs. A starting point in the discussions will be the UN Sevilla Commitment adopted in July 2025 at the Fourth International Conference on Financing for Development, which reaffirms the importance of well-designed PPPs as a key instrument to promote foreign direct investment (FDI). The session will highlight the key factors and explore strategies to attract sustainable finance in PPPs and infrastructure projects, including blended finance, green bonds, impact investment, and other innovative financing tools.³

B. Panel 2: Harnessing the potential of artificial intelligence (AI) in Public-Private Partnerships and infrastructure projects

5. AI offers transformative potential for enhancing the identification, implementation, and impact of PPPs and infrastructure projects, but it also presents challenges and risks. The panel will explore how AI can: assist in data collection; improve decision-making in the identification, planning and operational phases of projects; facilitate better communication and engagement with stakeholders; develop more efficient financial models, such as blended

finance; enhance the procurement process of infrastructure assets, and assist in monitoring and reporting.⁴

C. Panel 3: Promoting fiscal sustainability and tariff affordability in Public-Private Partnerships and infrastructure projects

6. Fiscal sustainability and tariff affordability are fundamental elements for governments to consider in all PPP projects. The panel will explore strategies and tools to ensure the fiscal sustainability of PPP projects, and for tariffs to be and remain affordable to users and taxpayers throughout the identification, development, and implementation phases of projects.⁵

D. First Meeting for Government Delegates only: Opportunities and challenges in advancing national Public-Private Partnerships programmes

- 7. The first Meeting for Government Delegates only⁶ will serve as a platform for sharing experiences, progress, and challenges in implementing national PPP programmes across the ECE region and beyond. The Meeting will foster peer-to-peer learning and facilitate the exchange of best practices, while also identifying capacity-building needs to support the development of sustainable and resilient PPPs and infrastructure projects.
- 8. The detailed programme of the policy discussion and the first Meeting for Government Delegates only will be developed in consultation with the Bureau and will be made available to participants on the ECE website.⁷

- 9. The Working Party will review the PPP work since its last session on 25 26 November 2024 on:
- (a) Policy documents: International PPP standards, guidelines, guiding principles, declarations, training material, and recommendations; and
 - (b) Implementation: Capacity-building activities and policy advisory services.

A. Policy documents: International Public-Private Partnerships standards, guidelines, guiding principles, declarations, training material, and recommendations

- 10. The following documents are being presented for information:⁸
- (a) Draft guidelines on promoting gender equality and women empowerment through PPPs for the SDGs (ECE/CECI/WP/PPP/2025/INF.3);
- (b) Draft guidelines on enhancing stakeholder engagement throughout the PPP project lifecycle in support of the SDGs (ECE/CECI/WP/PPP/2025/INF.4);
- (c) Draft guidelines on promoting climate resilient PPP and infrastructure projects in support of the SDGs (ECE/CECI/WP/PPP/2025/INF.5); and;
- (d) Draft standard supporting the use of off-grid rural electrification renewable energy and energy efficient PPP solutions (ECE/CECI/WP/PPP/2025/INF.6).
- 11. Drafting teams developing the above-mentioned documents paid particular attention to the rights of vulnerable people by adopting, where possible, a human-rights based approach to PPPs and infrastructure.
- 12. The Working Party will receive a progress report on the draft PPP standards, best practice guides and policy briefs at various stages of preparation and on the use of existing PPP standards, tools, and best practice guides.

13. In line with Rule 16 of the Rules of Procedure, an annual summary report of the Bureau decisions (ECE/CECI/WP/PPP/2025/INF.1) will be submitted to and presented at the Working Party for information.

B. Implementation: Capacity-building activities and policy advisory services

- 14. The Working Party will review the impact of capacity-building activities and the policy advisory services undertaken since the last session, noting the challenges arising, given the UN's ongoing liquidity crisis.
- 15. The Working Party will also have the opportunity to take stock of past PPP activities, discuss effective means for the promotion and dissemination of this work, and review, as appropriate, the evaluation undertaken by the UN Office of Internal Oversight Services (OIOS) in 2022, including recommendation 2 on the development of a division-wide integrated strategic plan covering subprogrammes 4 and 6.

- 16. The Working Party will discuss proposals for work to be undertaken in the remainder of 2025 and in 2026 in accordance with the Intersessional Implementation Plan for 2025 2026 approved by the Committee on Innovation, Competitiveness and Public-Private Partnerships (ECE/CECI/2025/2, Annex I).9
- 17. The Working Party will decide on the venue of the 10th edition of the UNECE International PPP Forum to be held in May 2026.¹⁰
- 18. Building on the document on future work prepared and presented by the Bureau at the last session (ECE/CECI/WP/PPP/2024/INF.2), the Working Party will have the opportunity

- to hear proposals to launch work in 2026 on new standards, guidelines and policy recommendations to be developed where the Working Party has a mandate. 11 New proposals are subject to interest by experts participating in drafting teams and the availability of resources.
- 19. The Working Party will discuss and decide on the Bureau proposals for future work on PPP policy documents (ECE/CECI/WP/PPP/2025/INF.2), and on proposals from delegations.
- 20. Participants are encouraged to communicate to the meeting any expressions of interest by member States or other stakeholders for receiving, delivering, or hosting capacity-building activities in the priority areas of the Working Party's work. Requests from member States for capacity-building activities and policy advisory services will be considered based on available capacity and resources.
- 21. Participants are also encouraged to bring to the attention of the session any expression of interest by member States and other stakeholders to provide extrabudgetary support towards the ECE PPP work in support of the SDGs (such as funding or in-kind contributions, including the organization of seminars and networking initiatives). The secretariat will brief the Working Party on requests received for capacity-building and policy advisory services, and the efforts underway to raise additional extrabudgetary resources to meet these requests.

- 22. At its fifth session in November 2021, the Working Party approved the Rules of Procedure contained in document ECE/CECI/WP/PPP/2021/5/Rev.1.
- 23. At its eighth session in November 2024, the Working Party requested the Bureau to review the Rules of Procedure, especially with regards to the nomination of observers to the Bureau, and, if deemed necessary, submit a revised Rules of Procedure to the Working Party at its ninth session.
- 24. The Bureau revised the Rules of Procedure adopted in November 2021, and recommend their adoption by the Working Party.
- 25. The Working Party will decide on the revised Rules of Procedure (ECE/CECI/WP/PPP/2025/3).

Item 6. Election of officers

26. The term of office of Bureau members expires at the end of the session and a new Bureau shall be elected pursuant to the Working Party's Rules of Procedure. The Working Party will elect its Chairperson and Bureau members for a two-year term.
