Implementing sustainable infrastructure and nature-based solutions in the UNECE Region: opportunities and co-benefits based on UNECE Environmental Performance Reviews

Objective:

The UNECE Environmental Performance Review (EPR) Programme assists and supports UNECE member countries in enhancing their environmental management and performance. The Programme is tasked with analysing the national contexts of countries within the pan-European region, and occasionally beyond, to prepare reports that may be used as the framework for multilateral or bilateral cooperation projects. Furthermore, these reports include a series of recommendations that beneficiary countries must implement over 5-10 years. Governments officially endorse these recommendations upon approval by the UNECE Committee for Environmental Policy in Geneva.

Sustainable infrastructure and nature-based solutions (NbS) are fundamental to promoting climate change mitigation and adaptation. This event's main objective is to facilitate an international dialogue on the potential for implementing sound measures for NbS in the UNECE region and beyond, with the support of International Financial Institutions (IFIs) and international donors and based upon UNECE Environmental Performance Reviews recommendations.

The event, organized by UNECE Environmental Performance Review Programme and the Italian Ministry for the Environment and Energy Security, Directorate-General for European and International Affairs and International Finance, will foster a comprehensive understanding of NbS and sustainable infrastructure concepts and benefits, share regional and international case studies, and explore policy and regulatory frameworks enabling NbS and sustainable infrastructure implementation. The workshop aims to enhance collaboration among IFIs, academia and the private sector, highlighting the role of each in advancing NbS. Additionally, the workshop will focus on identifying funding opportunities, practical steps for project implementation, and monitoring and evaluation methods to ensure the effectiveness and sustainability of initiatives. Participants will gain valuable insights and discuss actionable ideas through interactive sessions and discussions.
