Multi-Stakeholder Round Tables

The Multistakeholder Roundtables open on 30 June with a powerful session on **"Mobilizing and Aligning Domestic Public Resources"**, co-chaired by the Presidents of Estonia and Sierra Leone, with a special address by the President of Ecuador and a keynote by the Prime Minister of Ukraine. Featuring finance ministers from Spain, Germany, Senegal, and senior representatives from the IMF, ADB, and EIB, the roundtable will tackle how to strengthen domestic capacity to fund development—laying the groundwork for national ownership and sustainable progress.

This will be followed at 5:45 p.m. by a Policy Dialogue on "Making Blended Finance Work", featuring the heads of IDB, EBRD, Standard Bank, the Gates Foundation, and senior officials from Egypt and Indra, with Lord Nicholas Stern moderating. Together, these sessions promise cutting-edge insights into translating FFD4 commitments into reality.
