### Introduction

Strengthened collaboration and the sharing of information between the various actors of the IED sector, including humanitarian, private sector, industry, military and academic representatives can enhance solutions in IED Threat Mitigation. Partnerships can contribute to a common understanding of threats, building on lessons learned from various actors in areas such as types of incidents, impact of incidents on civilians, prevailing trends, the design of devices and initiation mechanisms, specific equipment needs, and available training and technologies for safe removal. The sharing of information and increased dialogue can be key to operational effectiveness in an IED threat environment, and can better protect lives and infrastructure.

# Purpose of the Session

This plenary will discuss how partnerships among various stakeholders can enhance humanitarian responses in order to protect civilians, ensure that mine actors are equipped and trained to safely mitigate threats, and promote the development of technological solutions. The session will discuss the importance of institutional arrangements in fostering information sharing within national agencies to contribute to effective and coherent national responses to IED threats, which can draw from the lessons learned, expertise and capabilities of other agencies. The sharing of information and knowledge between mine action and other humanitarian actors is critical to better protection of civilians through a common understanding of the threat posed and the impact on communities and infrastructure.

The discussion will also look at the contribution of the private sector to IED threat mitigation responses through technologies, and the role of research in promoting innovations and in contributing to a shared analysis of the national and regional impact of IED threats, trends on IED incidents, origin of components, transfer of knowledge, and others.
